## Get your mandatory QCI continuing education at a time and place that is most convenient for you!

If you are a QCI (Qualified Credentialed Inspector), you are required by ADEM to take a 4-hour continuing education course each year through your original provider to maintain your certified status. The Home Builders Association of Alabama (HBAA) offers two ways to obtain your continuing ed credit.

The HBAA offers online stormwater certification continuing education. Online training not only saves you the time you would normally spend away from your office, but you will pay just \$80 compared to \$125 for the classroom training. Take the course at your own pace in the comfort of your home or office.
